# Old Business

#### 1. OUTDOOR GALLERY PROGRAM

#### DISCUSSION

Von Trotha and Landry met with Morrison Gravel, selected the stones and Morrison is prepping two stones and plates. Threshold Group was contacted and will donate up to \$900 for the second stone. Both will be positioned on Harborview Drive in front of the Russell Foundation. Public Works will need 2-week notice prior to installation of bases. Installation is expected end of summer. Both basalt stones will be hexagonal shaped with colors appearing (reds and browns) over time. Glock-Jackson will help with press release and contact lists. Commissioners reviewed sample "call for artists". Edited document will be circulated by staff prior to next meeting. Plaque for donated basalt pedestal should paid by City. Plaque for artwork should be created by artist and include: name of artwork, medium, artwork name and contact information. Art "may" be for sale but must handled directly between artist and buyer. Von Trotha priced donation plaques at approximately \$170/each for cast bronze.
