REQUEST FOR LETTER OF COMMITMENT

ORDINANCE NO. 606

AN ORDINANCE of the City Council of Gig Harbor, Washington, approving an amendment to Ordinance No. 604, of the City to change the dated date of the bonds authorized therein.

WHEREAS, to finance a portion of the cost of certain road improvements in the City of Gig Harbor (the "City"), the City Council of the City passed on July 22, 1991 Ordinance No. 604, authorizing the issuance and sale of limited tax general obligation bonds in the aggregate principal amount of \$900,000 (the "Bonds")

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF GIG HARBOR, WASHINGTON, AS FOLLOWS:

<u>Section 1.</u> <u>Definitions</u>. Unless otherwise defined, capitalized terms used in this ordinance shall have the same meanings given to such terms in Ordinance No. 604 of the City Council.

<u>Section 2</u>. <u>Amendment of Section 3 of Ordinance No. 604</u>. The first paragraph of Section 3 of Ordinance No. 604, of the City Council is hereby amended to read as follows (with additions underlined and deletions stricken through):

Section 3. Authorization of the Bonds. The City shall now issue and sell \$900,000 of bonds required to pay the cost of the Project (the "Bonds"). The Bonds shall be designated "City of Gig Harbor, Washington, Limited Tax General Obligation Bonds, 1991," shall be dated as of [<u>August 1</u>]July 1, 1991, shall be fully registered as to both principal and interest, shall be in the denomination of \$5,000 each, or any integral multiple thereof, provided no Bond shall represent more than one maturity, shall be numbered separately in such manner and with any additional designation as the Bond Registrar deems necessary for purposes of identification, and shall bear interest from their date at the following per annum rates, payable on June 1, 1992, and semiannually thereafter on the first days of each succeeding December and June and shall mature on December 1 of the following years in the following principal amounts:

RE: Conversion of City From Mayor Council to Council Manager Form of Government

State law has set up the process whereby the voters of a code city may elect to abandon the current form of government and choose an alternate form of government. The Council has directed the legal staff to focus on the change to a Council-Manager form of government as authorized by Chapter 35A.13 RCW.

RCW 35A.06.030 provides that the Council by resolution may call for an election on the question of whether the City should abandon the Mayor Council form of government and adopt instead the Council-Manager as specified in RCW 35A.13. RCW 35A.13.010 specifies that if the city's population is over 2,500 the council must consist of seven members, subject however to this number being reduced to five as explained later in this memo.

The election to determine whether the City will change its form of government must be voted on at the next general municipal election if one is to be held within 180 days of adoption of the resolution, otherwise at a special election. Thus, if the Council acts on this issue soon, the election to determine whether the form of government will be changed must be held at the general election on November 5, 1991. (RCW 35A.06.050). The resolution must be presented to the Pierce County-Auditor at least 45 days prior to the election, or by September 20. The ballot title and statement of the proposition must be prepared by the City Attorney. (RCW 35A.06.050).

If the vote at the November 1991 election is favorable, then the members of the City Council must stand for election. Assuming the election on the question of the change of government occurred 1991, then the election for City Council in November of candidates would be held at a special election preceded by a The possible dates for the primary and the special primary. election are February 4, 1992, March 10, 1992, April 7, 1992 or May 26, 1992. After the election and change of government, the City Council would enact a resolution 45 days prior to the proposed date asking the Auditor to set the election on the dates chosen by the Council. At that election, positions one through three would serve until January 1994 and the remainder until Elections would occur in November 1993 for January 1996.

RCW 35A.13.010 provides that cities over 2,500 population must have a seven member council. However, for cities of less than 5,000 who have a seven member council, the council can elect to reduce the number of council offices to five. At least six months prior to a municipal general election, the City Council adopts an ordinance providing for a reduction in the number of councilmanic offices to five. The ordinance must specify which two councilmanic offices, the terms of which expire at the next general election are to be terminated. The ordinance provides for renumbering of the existing positions and provides for a The earliest this could occur would be in November transition. of 1993 when three of the council positions would be up for election. As stated the Council would designate two of those positions to expire. Therefore, if the Council elected this option there would be only one seat in November of 1993 and beginning January 1, 1994 the Council would again have five members.

RCW 35A.13.033 also provides that the Council may submit a proposition to the voters to designate the person elected to Council position one as the chair of the council who would have the powers and duties set forth in RCW 35A.13.030. Although not specifically referenced in the chapter on reorganization of a code city, it is my opinion that such a proposition could be submitted in conjunction with the proposal to reorganize to a Council-Manager form of government under RCW 35A.13.

I have provided the council with a proposed resolution showing the designation of council chair in brackets.
