A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GIG HARBOR ACCEPTING THE ANNEXATION PETITION FOR THE AREA KNOWN AS WEST SUTHERLAND STREET SUBMITTED BY PETITIONER JAMES RICHARDSON, AND ENTERS AN INTENT TO APPROVE AND REFERRING THE PETITION TO THE PIERCE COUNTY BOUNDARY REVIEW BOARD.

WHEREAS, on the 11th day of July, 1991, a petition for annexation was submitted for the property lying west of Sutherland Street; and,

WHEREAS, the petition and legal description of the subject property are attached as Exhibit "A" to this resolution and made a part hereto; and,

WHEREAS, such annexation proposal is within the Urban Area Boundary as defined in the Urban Area Agreement of September, 1987, between Pierce County and the City of Gig Harbor; and,

WHEREAS, such annexation proposal is within the future potential annexation area as defined by the City of Gig Harbor; and

WHEREAS, on the 12th of August, 1991, the City Council met with the initiating party during regular session of the Council; and,

WHEREAS, at that time the Council set forth the requirements placed on the petitioner wishing to annex as follows:

- Assumption by the property owners their portion of the City of Gig Harbor's indebtedness;
- The area shall be zoned as single family residential (R-1), subject to the City of Gig Harbor Zoning Code, Title 17 of the Gig Harbor Municipal Code.

WHEREAS, on August 13th, 1991, a determination of non-significance was issued for the proposal, based upon a review of the environmental documents submitted by the Resolution Accepting Annexation Petition for J. Richardson. Page 2 Resolution #

petitioner, in accordance with the City of Gig Harbor Environmental Policy Ordinance, Title 18 of the Gig Harbor Municipal Code;, and,

WHEREAS, at the public hearing of September 9th, 1991, the City Council does hereby declare its intent to authorize and approve said annexation, and to accept same as a part of the City of Gig Harbor; and,

WHEREAS, the City Council shall comply with the procedural requirements of RCW 35A.14 to the conclusion of this annexation.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GIG HARBOR:

Section 1. The City Council of the City of Gig Harbor does hereby declare its intent to authorize and approve the annexation and to accept the subject property as part of the City of Gig Harbor with the following requirements:

- The area shall be zoned single family residential (R-1).
- 2. The property owners within the annexed area shall assume a pro-rata share of the City's bonded indebtedness.

Section 2. The City Clerk of the City of Gig Harbor hereby declares the annexation petition contiguous with the boundaries of the City of Gig Harbor and said property which is more particularly described in the petition which is marked Exhibit "A" and which is made a part hereto. The City Council does refer the petition and petitioner to the Pierce County Boundary Review Board for approval of the annexation and the City Council shall not take any further action on the annexation proposal until such time the Pierce County Boundary Review Board has completed its review of the notice of intent to annex. Each year the city is required to update its six-year transportation plan for street improvements. To be able to use the motor vehicle fuel tax funds and to request federal and state funds (i.e., FAUS, TIB), this plan must be updated annually and the funds used for a project shown on the plan.

This year's plan includes a total of twelve projects to be done over a six year period. It is very similar to last years plan. The plan is revised each year and the city is under no obligation to the Department of Transportation to maintain the same priorities from year to year.

The majority of the projects on the plan are reconstructive type projects. Only one, Milton Avenue, is a new construction project. Please find enclosed a narrative for a detailed explanation of each project.

The amount of money we receive from the gas taxes revenues is not enough to implement our six-year street plan. Legislators have recognized that and have provided a development impact fee option for the cities and counties. This option is already being utilized by some jurisdictions. In order to keep the current level of standards for our transportation system, we would need to generate new revenues. We can generate these revenues by implementing the development impact fee option upon completion of our Comprehensive Transportation Plan.

Recommendations

Staff recommends that council approve the attached Six-Year Transportation Plan for 1992-1997, and pass the adopting resolution.

CITY OF GIG HARBOR 1992 - 1996 SIX-YEAR TRANSPORTATION IMPROVEMENT PLAN NARRATIVE

1) SOUNDVIEW DRIVE/HUNT STREET

The existing Portland Cement Concrete pavement has deteriorated. This project proposes to rebuild roadway structure with Asphalt Concrete Pavement. A two lane street with a bike lane, curbs, gutters, and a sidewalk on one side of the street will be provided with this project. Telephone utility lines will be undergrounded and conduits will be provided for the power line in the future. The existing safety problem at the Harborview and Soundview intersection and storm drainage will also be addressed.

Preliminary engineering work of this project has been completed and funding secured. The final design of the project will be completed this year and the construction next year.

The Hunt Street project is proposed to build curbs, gutters, and sidewalks along with enclosed storm drainage systems on one side of Hunt Street, between Kimball Drive and Soundview Drive.

This project can be incorporated with the Soundview project, increasing the total size, thus lowering the unit bid price of construction items.

2) NORTH HARBORVIEW DRIVE

This project consists of storm drainage, curbs, gutters, and sidewalk improvements. Existing pavement will be overlayed with asphalt concrete pavement and any deficiency related to signage and pedestrian circulation will also be addressed.

The city had budgeted \$12,000 for this project in 1991. The plans are being finalized and the funds will be spent this year.

An additional \$75,000 would be needed for the project completion next year.

3) MILTON AVENUE

The portion of Milton Avenue between Vernhardson and Hunt has not been developed, but the right-of- ways have been reserved for future developments. This project proposes to build this portion of Milton Avenue as a two-lane roadway with curb, gutter, and sidewalk on one side of the street. Enclosed drainage system will also be provided.

Final engineering work on this project has been completed and funding will be available through private developers. The city has already been approached by a developer to improve this portion of Milton Avenue.

4) KIMBALL DRIVE

The proposed improvements with this project consist of two through lanes (one each direction), one two-way left turn lane, a bike lane, curbs, gutters and sidewalks on both sides of the streets. A fully actuated traffic signal at the Kimball/Pioneer intersection, enclosed storm drainage system and illumination along the length of the project will also be constructed.

Preliminary engineering work of this project has been completed and a funding source in unknown at this point.

5) STINSON AVENUE

The purpose of this project is to rehabilitate the deteriorated existing pavement. Minor street widening will be included in the scope of this project to improve the surface of the existing shoulder and to improve the surface drainage.

Funding sources for this project are not known, but the local funds would most likely be the only source of funds to complete this project. Six-year Transportation Improvement Plan Page 3

6) ROSEDALE STREET

The purpose of this project is to repair the existing pavement. The street should be overlayed with 1-1/2" thick asphalt concrete pavement one year after the various patching and crack sealing jobs completed with this project.

The city funds appear to be the only source of funds for this project. The project is scheduled to be completed in 1992.

7) PRENTICE STREET

8) BURNHAM DRIVE

These projects propose to build curbs, gutters, and sidewalks along with an enclosed storm drainage system on one side of each street. The projects are being proposed primarily to address storm drainage problems and pedestrian safety issues.

Funding sources for these projects are not known at this point, however, some funds may be available from the school district as well as private developments.

9) PIONEER WAY

Engineering work for this project is scheduled to begin in 1993. The proposed improvements consist of minor widening, curb, gutter, sidewalk, and enclosed storm drainage system.

Funding sources for this project are not known at this point. It was put on the six-year plan to: 1) define the necessary improvements, and 2) to identify funding sources.

10) REPAIR AND RESTORATION OF VARIOUS STREETS

This proposes paved roadway surfaces and storm drainage improvements on various public alleys throughout the city.

11) VARIOUS OVERLAY

The city owns approximately 16 miles of asphalt paved roads within the city limits. The roads are very expensive to build. In order to protect the city's investment and to extend the useful life of roads, some type of maintenance should be implemented. The total of \$50,000 has been scheduled for 1990 with this sixyear plan to address such problems.

WHEREAS, pursuant to the requirements of Chapters 35.77 and 47.26 RCW, the City Council of the City of Gig Harbor has previously adopted a Comprehensive Street Program, including an arterial street construction program, and thereafter periodically modified said Comprehensive Street Program by resolution, and

WHEREAS, the City Council has reviewed the work accomplished under the said Program, determined current and future City street and arterial needs, and based upon these findings has prepared a Six-Year Transportation Improvement Program for the ensuing six (6) calendar years, and

WHEREAS, a public hearing has been held on the said Six-Year Transportation Improvement Program, and

WHEREAS, the City Council finds that there will be no significant adverse environmental impacts as a result of adoption or implementation of the Six-Year Transportation Improvement Program, NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF GIG HARBOR, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

<u>Section 1.</u> <u>Program Adopted</u>. The Six-Year Transportation Improvement Program for the City of Gig Harbor, as

PUGET SOUND REGIONAL COUNCIL COMES INTO EFFECT

It's official. Get used to the initials "PSRC" or "RC."

After three years of debate and a half-dozen rounds of proposals, local governments have approved formation of the Puget Sound Regional Council (PSRC), replacing the Puget Sound Council of Governments (PSCOG).

Seattle Mayor Norm Rice chaired the first meeting of the new council's Executive Board last week (August 21) at the Seattle Municipal Building.

The board took numerous actions to assume the duties and financial assets and liabilities from the PSCOG, as well as regional planning authority under state and federal laws.

The PSRC came into effect the week of August 19 when the number of cities and counties approving an interlocal agreement crossed threshold requirements.

The agreement or charter provided that in order for the new regional organization to come into effect, 45 jurisdictions in King, Kitsap, Pierce and Snohomish counties -- or 60 percent of a possible 75 cities and counties -- representing 2,061,671 people, or 75 percent of the region's population -- had to approve.

As of August 26, 50 jurisdictions -- 46 cities and the four counties -- had approved, representing 2,612,575 people, or 95 percent of the population.

A number of local councils have yet to take action. Among major councils that have approved the pact are the county councils and commissions of King, Kitsap, Pierce and Snohomish counties and the city councils of Seattle, Tacoma, Everett, Bellevue and Bremerton. The PSRC Executive Board will meet again at 12 o'clock noon, September 26, in the PSCOG conference room, immediately after the last or nearly last meeting of the PSCOG Executive Board. The PSRC general membership, or Assembly, is set to convene September 30, with officers election and budget and bylaws adoption slated.

Actual operation of the new council will begin October 1.

The PSRC Executive Board will have 21 members with 19 votes, and a weighted voting system providing half of the weighted votes for counties and half for cities. The COG had a 28-member board.

Like COG, the RC will be the federally designated "metropolitan planning organization (MPO)" for the region, preparing the regional plan for surface and air transportation and determining how hundreds of millions of dollars in federal transportation funds are distributed.

The PSRC will also be the "regional transportation planning organization (RTPO)" under state law, responsible for certifying the transportation elements of local comprehensive plans under the growth management acts.

Whereas the COG interlocal agreement was vague as to duties and authority, the RC charter is specific.

The PSRC will set some priorities for regionally significant transportation projects. It will certify that major transportation projects are consistent with the regional transportation plan. It will comment on private and public proposals potentially significant to the plan's implementation.

The pact says the PSRC will maintain VISION 2020, landmark product of the COG, as the regional growth management strategy. In a year or more the PSRC is to consider taking on review of countywide policy plans for consistency with VISION 2020.

Business and the public will be included on the PSRC's regional transportation policy board (newly required in state law) and on a regional growth management board.

- A safety and health committee composed of the following members shall hereby be created:
 - a) City Administrator
 - b) Public Works Director
 - c) Police Chief

- d) two councilmembers
- The safety committee shall have an elected chairperson.
- 3) The safety committee shall be responsible for determining the frequency of committee meetings; however, the committee shall meet at least once a year.
 - a) The committee shall be responsible for determining the date, hour, and location of the meeting.
 - b) The length of each meeting shall not exceed one hour, except by committee majority vote.
- Minutes of each committee meeting shall be prepared and filed for a period of at least one year.
- 5) The safety committee meetings shall address the following:
 - a) Review of safety and health inspection reports to assist in correction of identified

unsafe conditions/practices.

- b) Evaluation of accident investigations conducted since the last meeting to determine if the cause of the acts/conditions involved was properly identified and corrected.
- c) Evaluation of the accident and illness prevention program with a discussion of recommendations for improvement where indicated.
- d) Meeting attendance shall be documented.
- e) Subjects discussed at the meeting shall be documented.
- <u>f)</u> Issues may be presented for discussion by any member of the committee.

Attached for your consideration is a request for consideration to annex approximately 95 acres of land located predominantly west of SR-16, extending from the Wollochet Drive interchange, north along SR-16 to include three parcels South of Rosedale Street. A petition bearing the signatures of the owners of approximately 25% of the assessed evaluation within the annexation area is included. A minimum of ten percent is required for consideration of the petition.

The petitioner requests that the land be designated under several zoning districts under the city Zoning Ordinance, including residential and a commercial/business designation. Consequently, a pre-annexation zoning hearing before the city Planning Commission would be required.

If the petition is accepted by the Council, the petitioner will submit a zoning designation proposal for consideration by the city Planning Commission sometime in the fall. With the submittal of a 60% petition and the required environmental documents, a resolution for acceptance of the annexation will be presented to the Council. Upon completion of all review procedures by the Pierce County Boundary Review Board, an ordinance adopting the annexation will be presented for Council action.

Upon acceptance by the Council, the petition for annexation should include the requirement for the assumption of existing city indebtedness on a pro-rata basis and that the are to be annexed shall be subject to pre-annexation zoning hearings before the Planning Commission and the City Council. Additional requirements, as may be appropriate, can be considered.

Dear Mr. Wilson:

You had requested some additional information concerning the preliminary work we have done with property owners lying within the area currently being petitioned for annexation to the City of Gig Harbor. Prior to filing the 10 percent petition, we sent letters to the property owners within the area we were considering for annexation. While not all of the property owners responded, we did receive comments from some of the parties involved and spoke with several others. Attached are copies of the letters we sent to them with their responses. As you can see, the majority of the responses were favorable and they constitute a total of 28 percent of the assessed evaluation for the area involved. I have also included copies of the assessment role with the individuals who responded in favor, noted as well as illustrated their parcels on the annexation base map (see attached).

As I indicated to the City Planner, the property owners will be petitioned for zoning of this area with annexation. The Comprehensive Plan shows land use classification ranging from residential to business within the area. I am currently completing development of a proposed zoning map for the area which I have been reviewing closely with the City Planner. I would suggest that the best way to proceed would be to bring the 10 percent petition before the City Council at their regularly scheduled August 12th meeting at which time it can be accepted. I would hope that we could have already pre-selected a public meeting date which could be announced at that time, and I will be happy to send out notices to all property owners involved for a meeting at the City Hall.

I will make sure the zoning map is available along with copies of the 60 percent petition so that we can try to secure the remaining signatures for submission of the 60 percent petition. If we are successful in garnering those signatures, we can then prepare the necessary supporting documentation and file the matter with the City Council.
